It's sometimes hard but try not to pay too much attention to those who think conventionally or don't want you to succeed.


I would love to hear about your plan and, when it succeeds, have you on my podcast to discuss your journey.

AB 1000 Pulled from Consideration **Before State Assembly Local Government Committee Hearing**

Facing strong opposition, AB 1000 was pulled from consideration on Wednesday, January 10, 2024, by its author, Assemblymember Reyes, before a hearing in the CA State Assembly Local Government Committee. AB 1000 was opposed by both Democrats and Republicans on the Committee. Hundreds of NAIOP SoCal members and allies across the state mounted

significant opposition to AB 1000 by contacting members of the Local Government Committee.

"I want to thank NAIOP SoCal members and allies for taking action against AB 1000. This grassroots opposition has been critical to stop AB 1000, which is a *de facto* moratorium on the development or expansion of logistics and warehousing uses," said NAIOP SoCal CEO, Timothy Jemal. "I also thank Democrats and Republicans on the Local Government Committee for continuing to oppose draconian legislation stripping local government control over land-use decisions

Thank you to NAIOP SoCal's Senior Government Relations Director, José Cornejo who has spent the last three days in Sacramento advocating against the passage of AB 1000. A shout-out to NAIOP SoCal's Government Relations Manager, Mihran Toumajan, for spearheading the grassroots opposition.

NAIOP SoCal will remain vigilant on this issue and continue working closely with allies and our Sacramento partner, CBPA, as well as NAIOP IE and all NAIOP Chapters across the state. It's possible legislation similar to AB 1000 could be introduced by any State Legislator as early as late February 2024.

We will continue to update members and allies on this critical issue.
