

Legislative Affairs Update







I.CON WEST - SoCal's South Bay Industrial Tour

On Monday 03/11, as a key feature of NAIOP's premier and annual I.CON West industrial real estate conference in Long Beach, California, attendees were fortunate to visit three distinct industrial sites in SoCal's South Bay region. NAIOP SoCal CEO, Timothy Jemal and Government Relations Manager, Mihran Toumajan participated in the SoCal Industrial Tour.

Prior to the delegates' arrival at the first industrial site, Cushman & Wakefield of California, Inc. Executive Directors Steve Bohannon and Rusty Smith provided an overview of the South Bay industrial market to SoCal Industrial Tour participants. The SoCal Industrial Tour was presented by Majestic Realty, to which we extend our sincere gratitude.

NAIOP SoCal thanks Lang Cottrell and Jim Cottrell of Goodman, Lance Ryan and his team at Watson Land Company, and Brian Wilson and Greg Stumm of Bridge Industrial for warmly welcoming site tour participants to their impressive, Class A industrial properties located in Long Beach, Carson and East Torrance (the latter part of unincorporated Los Angeles County) respectively.

The three South Bay industrial sites feature projects in disparate phases of completion and range in size from 165,000 to 500,000 square feet.

NAIOP SoCal Engaged in South Coast AQMD's Working Group on Air Quality Cumulative Impacts for CEQA Projects

On March 20, 2024, the South Coast Air Quality Management District (AQMD) held its fifth working group meeting on "Cumulative Impacts from Air Toxics for CEQA Projects." Per CEQA requirements, the working group has met since February 2022 to involve a wide swathe of stakeholders in analyzing direct, indirect and cumulative air quality impacts in the South Coast Air Basin, and developing guidance to evaluate such impacts for CEQA projects. AQMD's presentation is available at this link

NAIOP SoCal is especially concerned over AQMD's newly proposed criteria in determining and adjusting the cumulative significance threshold for Health Risk Assessments under CEQA. While the current threshold, based on 2018 data, is 10 cancer cases in one million people, AQMD's proposed criteria could adjust the threshold to as low as 1 to 3 cases in one million. Further, AQMD's proposed criteria suggest that as few as 91 one-way truck trips per day would trigger a Calculated Cancer Risk threshold of 100 cases in one million. Calculating the number of truck trips per day is required under AQMD's Warehouse Indirect Source Rule (Rule 2305) and its WAIRE program, which imposes a compliance obligation on warehouse operators based on the number of truck visits to a warehouse per year.

NAIOP SoCal is engaged with the AQMD working group and will continue to monitor and report new developments to members and concerned stakeholders.
