URGE CALIFORNIA STATE
ASSEMBLYMEMBERS
TO OPPOSE SB 1103

State Assemblymembers are Back in Session: TAKE ACTION NOW and Urge Assemblymembers to Vote "No" on SB 1103

A state bill upending landlord-tenant relationships will be debated and voted on the State Assembly Floor in August 2024. The bill – SB 1103 (Menjivar) – will disrupt landlord-tenant relationships in commercial contracts, place restrictions on cost allocation adjustments and add complex regulations to the business-to-business relationship. SB 1103 will have detrimental consequences not only on commercial landlords but on small businesses and nonprofit organizations that the bill is trying to protect.

NAIOP SoCal is asking our Members and friends to contact State
Assemblymembers, urging them to oppose SB 1103. It only takes a minute of
your time to respond to NAIOP SoCal's Action Alert, by emailing (Note: Submit a
pre-written email) and/or calling your State Assemblymember (Note: Follow the
supplied phone script as a guide).

SB 1103 is harmful to commercial property owners and tenants because it:

- Fails to recognize the fundamental uniqueness of business-to-business relationships in lease contracts and negotiations.
- Makes it more difficult for undercapitalized small entrepreneurs to secure leases and hinders the growth of start-up businesses.
- Jeopardizes the potential for flexibility and mutual benefits when a commercial landlord and tenant negotiate a lease or contract.
- Prohibits a property owner's ability to allocate and recover building operating
 costs in a manner that increases a tenant's share of those costs during the
 tenancy. Critical costs that property owners would not be able to recoup
 include emergency repairs; rising insurance premiums; property tax increases;
 major capital improvements; compliance with new safety, environmental or
 accessibility regulations; inflation-related increase in operating costs; and
 enhancements to address unforeseen security measures.

- Imposes complex and ambiguous regulations, which will disproportionately burden small to mid-sized commercial property owners.
- Heightens legal risks, uncertainty and administrative burdens, especially for "mom and pop" property owners, due to onerous and costly documentation and translation requirements.

<u>Please take action now</u> and encourage your co-workers and friends to do so as well. Thank you for your attention and advocacy on this important legislative issue.

LA County Board of Supervisors Pass Motion on Onerous Commercial Leasing Mandates

NAIOP SoCal Testifies in Opposition

During the Los Angeles County Board of Supervisors' meeting on July 9, 2024, a motion proposing mandates on commercial leases was introduced by Supervisors Holly J. Mitchell and Hilda L. Solis and ultimately approved by the full Board. Today's motion



asks the LA County Department of Economic Opportunity (DEO) to hire a consultant to perform an economic analysis of commercial rents across the County, to engage with nonprofit and small business organizations in providing recommendations and a potential "model lease," and to identify and recommend additional health and safety standards relative to commercial tenancies. The motion calls for commercial tenant protections for small businesses with less than ten employees and nonprofit organizations with fewer than twenty employees. The motion, however, is laden with detrimental provisions for commercial property owners, including burdens on landlords to cover potential tenant relocation fees.

NAIOP SoCal Senior Government Relations Director, Jose Cornejo, testified at the meeting in opposition to the motion. NAIOP SoCal was one of only two business organizations to testify in person at the meeting. In his testimony, Cornejo explained fundamental differences between commercial and residential leases, and expressed concern that the motion would create additional barriers to entry for small and minority-owned businesses due to concerns over an increased scrutiny of creditworthiness. Cornejo also emphasized that the motion would place additional burdens on small business owners facing unsustainable leasing terms and conditions, including mandatory relocation expenses and modified health and safety standards. Jose's testimony complemented NAIOP SoCal's opposition letter to the motion, submitted for the public record.

Supervisor Kathryn Barger referred to opposition letters received from NAIOP SoCal and other business groups, and warned about the motion's unintended costs and consequences for small business owners. Supervisor Barger recommended that business community and commercial property stakeholders be involved in a forthcoming economic impact analysis initiated by the DEO. In response to Supervisor Barger's concerns, DEO Director Kelly LoBionco affirmed that "all commercial stakeholders would be engaged as part of our economic analysis." In addition, during deliberations Supervisor Mitchell's staff approached Cornejo and expressed their desire for NAIOP SoCal to continue providing input and expertise throughout the process.

The motion ended up passing with a 5-0 vote.

Earlier this year in the California legislature, State Senator Caroline Menjivar (D-20) introduced a bill (SB 1103) on commercial lease contract mandates for small businesses and nonprofits, which LA County's motion mirrors. While SB 1103 will likely face a Floor vote in the State Assembly next month, working with our Sacramento partners – California Business Properties Association – and other trade associations, NAIOP SoCal has helped weaken the scope and impact of SB 1103 throughout the legislative process.

"I thank Jose for his testimony today on behalf of NAIOP SoCal to the Board of Supervisors to take the legitimate concerns of small and minority-owned businesses – owners and tenants – seriously. NAIOP SoCal looks forward to engaging with DEO staff in shaping the proposed economic analysis on commercial leasing," stated Tim Jemal, CEO, NAIOP SoCal.

NAIOP SoCal will keep its Members posted and engaged on new developments regarding Los Angeles County's proposed commercial leasing mandates.
